- **Organisational protective measures** No special measures required.
- **Technical protective measures**  
  - No special measures required.
  - Ensure that suitable extractors are available on processing machines
  - Use product only in enclosed systems.
- **Personal protective measures**  
  - Do not inhale gases / fumes / aerosols.
  - Avoid contact with the eyes.
  - Tightly sealed goggles
- **Measures for consumer protection** Ensure adequate labelling.
